I refer to your letter No. 147/D of 13 April 2022 requesting confirmation of the registration with the Secretariat of the United Nations of the Agreement of 15 November 1971 on the Establishment of the Intersputnik International System and Organization of Space Communications, as well as the deposit with the Secretary-General of the United Nations of the declaration of acceptance by the Intersputnik International Organization of Space Communications of the rights and obligations under the Convention of 12 November 1974 on Registration of Objects Launched into Outer Space.
